Recommended Dosage	Optimum dosage of SikaPlast®-315 PR should be determined by site trials. Recommended dosage: 0.1 – 2.0% by weight of cementitious. A higher dosage might be used if agreed by client or consultant. Stir well before use.
Compatibility	SikaPlast®-315 PR may be combined with many other Sika® Products. Compatible with all types of cements and cementitious materials. Important: Always conduct trials before combining products in specific mixes and contact our Technical Service Department for information about specific combinations.
Dispensing	SikaPlast®-315 PR can be added into the mixing water or directly into the concrete mixer after 50 – 70% of the mixing water has been added. The addition of SikaPlast®-315 PR to dry aggregate or cement is not recommended.  To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.
