Compatibility	Sikament <sup>®</sup> -113 may be combined with many other Sika <sup>®</sup> products. Compatible with all types of cements and cementitious materials. Important: Always conduct trials before combining products in specific mixes and combinations.
Dispensing	Sikament <sup>®</sup> -113 can be added into the mixing water or directly into the concrete mixer after 50 – 70% of the mixing water has been added. The addition of Sikament <sup>®</sup> -113 to dry aggregate or cement is not recom- mended. To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.
