Compatibility	Sikament [®] -2076 may be combined with many other Sika [®] products. Compatible with all types of cement and cementitious material. Important: Always conduct trials before combining products in specific mixes and combinations.

APPLICATION INSTRUCTIONS

DISPENSING

Sikament[®]-2076 can be added into the mixing water or directly into the concrete mixer after 50 - 70% of the mixing water has been added.

The addition of Sikament[®]-2076 to dry aggregate or cement is not recommended.

To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.

LIMITATIONS

Excessive water addition or overdosing may cause bleeding or segregation.

Overdosing may cause extension of initial and final setting times.

If frozen and / or if precipitation has occurred, Sikament®-2076 may be used after thawing slowly at room temperature and after intensive mixing.
