Recommended Dosage	Optimum dosage of SikaPlast®-5202 NS2 should be determined by site trials. Recommended dosage: 0.2 – 2.0% by weight of cementitious. A higher dosage might be used if agreed by client or consultant. Stir well before use.
Compatibility	SikaPlast®-5202 NS2 may be combined with many other Sika® Products. Compatible with all types of cements and cementitious materials. Important: Always conduct trials before combining products in specific mixes and contact our Technical Service Department for information about specific combinations.

APPLICATION INSTRUCTIONS

DISPENSING

SikaPlast®-5202 NS2 can be added into the mixing water or directly into the concrete mixer after 50 – 70% of the mixing water has been added.

The addition of SikaPlast®-5202 NS2 to dry aggregate or cement is not recommended.

To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.

LIMITATIONS

Excessive water addition or overdosing may cause bleeding or segregation.

If frozen and / or if precipitation has occurred, Sika-Plast®-5202 NS2 may be used after thawing slowly at room temperature and after intensive mixing.
