Storage conditions	SikaPlast® PH 8323 must be stored where temperatures do not drop below +5°C. If product has frozen, thaw at +5°C or above and completely reconstitute using mild mechanical agitation. Store under cover, out of direct sunlight and protect from extremes of temperature.  Shelf life is 12 months when stored as above.  Failure to comply with the recommended storage conditions may result in premature deterioration of the product or packaging. As a guide, a dosage range of 600ml to 1800ml per 100kg of cementitious material is normally recommended. For additional information on SikaPlast® PH 8323 admixture or on its use in developing concrete mixes with special performance characteristics, contact your local Sika representative.
Dispensing	SikaPlast® PH 8323 is a ready-to-use liquid which is dispensed into the concrete together with the mixing water. The plasticising effect and water reduction are higher if the admixture is added to the damp concrete after 50 to 70% of the mixing water has been added. The addition of SikaPlast® PH 8323 to dry aggregate or cement is not recommended. Thorough mixing is essential and a minimum mixing cycle, after the addition of the SikaPlast® PH 8323, of 60 seconds for forced action mixers is recommended.
Compatibility	SikaPlast® PH 8323 may be combined with many other Sika® Products. Compatible with all types of cements and cementitious materials. Important: Always conduct trials before combining products in specific mixes and contact our Technical Service Department for information about specific combinations.
