#### APPLICATION INSTRUCTIONS

#### **DISPENSING**

SikaPlast®-4211 NS can be added into the mixing water or directly into the concrete mixer after 50-70% of the mixing water has been added.

The addition of SikaPlast®-4211 NS to dry aggregate or cement is not recommended.

To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.

#### **LIMITATIONS**

Excessive water addition or overdosing may cause bleeding or segregation.

If frozen and / or if precipitation has occurred, Sika-Plast®-4211 NS may be used after thawing slowly at room temperature and after intensive mixing.
