Dispensing	SikaPlast® RB 925 TN is a ready-to-use liquid which is dispensed into the concrete together with the mixing water. The plasticising effect and water reduction are higher if the admixture is added to the damp concrete after 50 to 70% of the mixing water has been added. The addition of SikaPlast® RB 925 TN to dry aggregate or cement is not recommended.
Compatibility	SikaPlast® RB 925 TN is compatible with most admixtures used in the production of quality concrete including normal, other mid-range and high-range water-reducing admixtures, air entertainers, accelerators, retarders, extended set-control admixtures, corrosion inhibitors, and shrinkage reducers. SikaPlast® RB 925 TN is also compatible with slag and pozzolans such as fly ash, metakaolin and silica fume.
