Dispensing	SikaPlast®-326 X can be added into the mixing water or directly into the concrete mixer after 50 – 70% of the mixing water has been added. The addition of SikaPlast®-326 X to dry aggregate or cement is not recommended. To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.
