### **APPLICATION INSTRUCTIONS**

#### DISPENSING

Sikament<sup>®</sup>-2041 NS can be added into the mixing water or directly into the concrete mixer after 50 - 70% of the mixing water has been added.

To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.

# LIMITATIONS

Excessive water addition or overdosing may cause bleeding or segregation.

Overdosing may cause extension of initial and final setting times.

If frozen and / or if precipitation has occurred, Sikament<sup>®</sup>-2041 NS may be used after thawing slowly at room temperature and after intensive mixing.
