Recommended Dosage	0.5% to 2.0% by weight of cementitious. Higher dosage may be used if agreed by engineer and consultant. Actual dosage to be finalised on the basis of site trials. Stir well before use.
Compatibility	Sikament <sup>®</sup> -111 may be combined with many other Sika <sup>®</sup> products. Compatible with all types of cements and cementitious materials. Important: Always conduct trials before combining products in specific mixes and combinations.
Dispensing	Sikament <sup>®</sup> -111 can be added into the mixing water or directly into the concrete mixer after 50 – 70% of the mixing water has been added. The addition of Sikament <sup>®</sup> -111 to dry aggregate or cement is not recom- mended. To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.
