Compatibility	SikaPlast <sup>®</sup> -3155 PQ may be combined with many other Sika <sup>®</sup> products. Compatible with all types of cements and cementitious materials. Important: Always conduct trials before combining products in specific mixes and combinations.

#### **APPLICATION INSTRUCTIONS**

#### DISPENSING

SikaPlast<sup>®</sup>-3155 PQ can be added into the mixing water or directly into the concrete mixer after 50 - 70% of the mixing water has been added.

The addition of SikaPlast<sup>®</sup>-3155 PQ to dry aggregate or cement is not recommended.

To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.

### LIMITATIONS

Overdosing may cause extension of initial and final setting times.

If frozen and / or if precipitation has occurred, Sika-Plast<sup>®</sup>-3155 PQ may be used after thawing slowly at room temperature and after intensive mixing.
